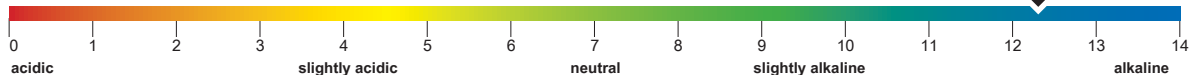

**Application:****High-pressure cleaner**
